01	How many students have taken admission through CSAB Round I & II in B. Tech (FTM) in 2019 but withdrawn their name after taking admission.	For B.Tech admission candidates list through CSAB round I and II has been generated by CSAB centralized counselling and is in JoSAA website and is open to all public. Regarding the admission withdraw by candidate there are two choices, the candidate can take admission by paying the online registration fee but not reported at centre, as well as, reporting at institute and then withdraw before last date. So, which data is required by applicant is not specified.
02	Whether session B.Tech (FTM) started on 16.08.2019,	Yes, B.Tech session has been started from 16.08.2019.
03	What was the last date for withdrawal of admission B. Tech (FTM) 2019 with full refund of fee as per NIFTEM rules.	The admission fee refund rules will be as per the JOASA/CSAB and then NIFTEM guidelines. The respective time line details provided in these websites as well as brochures/ business rules.
04	How many candidates taken in B. Tech (FTM) who paid the full fee but withdrawn admission up to 13.08.2019. Provide list of such candidates.	List of candidates paid the full fee and with draw their admission up to 13.08.2019 has been given as follows: a. Ms Yutika Khanna: Fee refund under process already initiated by admission cell and forwarded to accounts department.
05	Whether CSAB had transferred participation fee+seat allocation fee to NIFTEM in r/o YUTIKA KHANNA who has withdrawn admission from B. Tech FTM 2019 on 13.08.2019.	Yes, CSAB transferred the participation fee to NIFTEM. The respective refunds to the candidates are already under process as per the guidelines.
06	Why full fee not refunded in r/o YUTIKA KHANNA till date when admission has been withdrawn before commencement of session on 13.08.2019 as per rules.	The fee refund of applicant will be as per NIFTEM guidelines and processed for approval. After approval, the accounts cell will refund to candidates through Bank cheque or online transfer. The applicant Ms. Yutika Khanna refund has been processed and will be transferred to candidate.
