Again, based on RET conducted on 18th Sept 2020 and online interviews held between 24th and 25th Sept. 2020, following is the 2nd merit list of candidates for provisional admissions in PhD programme in different departments as per UGC regulation for PhD admissions, 2018 and its subsequent amendments and NIFTEM admission rules. All efforts have been made to make this list without error; however, in case of discrepancy, final result and merit as per record will be final and NIFTEM/admission cell reserves right to cancel/amend no. of seats at any point of time. Selection for admission to PhD is provisional and candidates should fulfill requirements mentioned in the admission brochure 2020-21; most of the following candidates have not uploaded correct certificates [marksheets, degree certificates, category certificates (esp. OBC candidates, EWS candidates – (latest NCL/EWS certificate)), etc. Please refer list of eligible candidates uploaded on 10th Sept. 2020 for deficiency documents]. Also, some of the following candidates have not uploaded/submitted “compulsory undertaking with respect to Master’s degree completion” (those candidates who are completing their master’s degree in 2020). **Admission cell, NIFTEM has adopted a highly lenient and flexible view considering CoVID-19 pandemic.** All such candidates are required to give undertaking (wherever applicable), submit all necessary documents before paying fees. If during later stage, any candidate is found to have forged documents, undertaking, or does not fulfill required qualification, their admission will be cancelled. **Part time candidates need to submit/show relieving certificate from the employer/parent institute with leave granted before paying fees; failing which seat will be offered to next candidate in waiting or may not be filled.**

The fellowship will be awarded to 02 candidates in each department. Merit will be strictly followed for award of fellowship in each category following due roster and same has already been uploaded on the website. No fellowship will be awarded to Part Time candidates.
