Important Instructions for Provisionally Qualified Candidates – M.Tech. Admission 2026-27 Through NIFTEM-K Entrance Exam

- **Last Date for admission fees payment of 1st Counselling:-** 20th July 2026 till midnight(11:59 PM). Payment to be done only using online link:- https://niftemevent.niftem.ac.in/admission_fees/fees.php
- As per the NIFTEM Entrance exam score, the seat allotment for 1st counselling is given below.
- The seat allotment for the First Round of Counselling has been prepared strictly on the basis of the NIFTEM-K Entrance Examination merit and the seat allocation carried out based on the order of program preferences submitted by the applicant in the online application and respective availability of vacant seat matrix.
- All efforts have been made to allot seats based on the candidates' subject preferences in the order of merit and admission guidelines. However, NIFTEM-K or any of its staff shall not be held responsible for any inadvertent errors that may have occurred in the published information. In case of any discrepancy, candidates may report the issue via email. Please note that such communication will be entertained only if the sender's email ID matches the one provided in the application form of the provisionally selected candidate.
- Candidates allotted a seat in the 1st **Counselling** are required to pay the **full admission fee** through the **NIFTEM admission portal** up to 20th July 2026 till midnight(11:59 PM) (Link: https://niftemevent.niftem.ac.in/admission_fees/fees.php). Candidates who fail to pay the fees within stipulated time of counselling schedule shall have to forfeit his/her claim for the seat and such candidates will not be considered for the next counselling rounds.

- ***No request for cancellation/withdrawal of admission shall be entertained after the payment is done. In case, if the selected candidates for the M.Tech programme (NIFTEM Entrance Exam) withdraw/cancel their admissions after the payment only security deposit amount of the total fees will be refunded***
- Candidates are advised not to pay the admission fee until their name appears in counselling as seat allotted/ fee payment notification on website and ***candidates marked as Waiting list in 1st counselling are not required to make any payment.***
- ***Candidates marked as waiting list in 1st counselling may get a seat in subsequent counselling rounds if candidates allotted a seat does not pay the fees within stipulated time. Such candidate shall check our website for the next round counselling merit list.***
- Preference upgradation shall be carried out in subsequent rounds of counselling based on seat withdrawals and the availability of vacant seats.
