Final Round of Counselling for Registered Candidates ONLY for Vacant Seats under B.Tech (FT) + MBA

Interested registered candidates are invited to participate in the Final Round of Counselling (in-person/physical only) for admission against the vacant seats under the B.Tech (FT) + MBA in their respective categories.

A Google Form (<https://forms.gle/tiQU8wssDdfy3YAX7>) will be shared with the individual eligible candidates remaining after the 3rd Round of Counselling, as per the list given below, to obtain their willingness for the aforementioned seats. The eligible candidates are requested to submit their responses by **13 August 2026, up to 5:00 PM**.

Candidates who indicate their willingness MUST report in person on **18 August 2026, latest by 12:00 PM**, along with all original documents and the required fee amount.

Merely expressing willingness to participate in the Final Round of Counselling does not guarantee a seat. Admission will be subject to the availability of seats and the applicable admission rules at the time of the Final Round of Counselling.

NOTE

- A mess fee of **Rs. 27,500/- for the first semester is payable** in addition to the above-mentioned fees.
- The candidate/guardian should ensure that sufficient transaction limits are available on their **UPI, credit card, or debit card** to make the above-mentioned payment in full on the same day.
- Candidates belonging to the OBC-NCL category must produce a valid OBC-NCL Certificate in the prescribed format, namely, "Form of Certificate to Be Submitted by Other Backward Classes for Appointment to Posts/Admissions to Institutes under Government of India." The certificate must have been issued on or after

01.04.2026 and must be submitted at the time of physical reporting at the Institute. Failure to produce the required certificate may result in cancellation of admission.

- Candidates belonging to the EWS category must submit a valid EWS Certificate issued on or after 01.04.2026 at the time of physical reporting. Failure to produce the required certificate may result in cancellation of admission.
- NIFTEM will not be responsible for any kind of delay/error occurred while paying the admission fee.
- All efforts have been made to allot the seats as per the order of merit. NIFTEM or any of its staff will not be responsible for any inadvertent error for any information being published.
- Admission offered after fee payment through this merit list is purely provisional and is subject to the verification of all original documents at the time of physical reporting. The admission and allotment of the seat shall be confirmed only after successful verification of the original documents and fulfillment of all prescribed eligibility conditions.
- In case a candidate wishes to withdraw/cancel their admission after payment of the full fee, only the security deposit shall be refundable, as per the applicable admission/refund policy.
