- **This is the final counselling; there will be no more rounds/counselling for seat allotment through GATE mode.** Vacant seat remaining post this round or till the last date of cancellation will be filled through NON-GATE/ NON-CUET entrance exam to be conducted at NIFTEM-K on 17th July 2026.
- *Candidates marked as Not allotted seat in final counselling may appear for the NON-GATE/NON-CUET Entrance Exam, if interested. After this final round of counselling available seat matrix with respect to Program and category will be uploaded on the NIFTEM website by 10th July 2026.*
- **Last Date for admission fees payment of final Counselling: - 09th July 2026 till 2.00 PM.** Payment to be done only using online link:-

- **Candidates who have already paid the admission fee during the 1st, 2nd, 3rd and 4th Counselling are not required to make the payment again.**
- As per the valid GATE score, the seat allotment for final counselling is given below.

- Candidates allotted a seat in the **final Counselling** are required to pay the **full admission fee** through the **NIFTEM admission portal up to 09th July 2026 2.00 PM** (Link: https://niftemevent.niftem.ac.in/admission_fees/fees.php). Candidates who fail to pay the fees within stipulated time of counselling schedule shall have to forfeit his/her claim for the seat and such candidates will not be considered for the next counselling rounds.
- Candidates are advised not to pay the admission fee until their name appears in counselling as seat allotted/ fee payment notification on website and **candidates marked as Not allotted seat in final counselling are not required to make any payment.**
- Those Candidates who have applied through both GATE and CUET and have been allotted seat in both of the admission modes in the final counselling merit list are required to pay the fees only once, depending on their preferred choice of branch or program. After the fee payment is completed, the seat allotted through the other mode (GATE/CUET) will be automatically cancelled. No further claim on the seat/branch and any requests for changes will be entertained thereafter. Such candidates will have to forfeit claim under their earlier mode of admission.**
- In case after conducting entrance exam for Non-GATE/Non-CUET candidates, If seats remain vacant, they will be filled through GATE/CUET waitlisted candidates. If still any of the ST seats remains vacant after exhausting all the options, they will be interchanged as mention in the NIFTEM-K admission brochure 2026.**
